A SPECIAL CITY COUNCIL MEETING AND WORKSHOP WAS CALLED TO ORDER BY MAYOR JEFF W. ROBERTS ON MONDAY, JULY 11, 2016 AT 4:06 P.M. IN THE CANE ROOM LOCATED AT 2700 TOWN CENTER BLVD. N IN SUGARLAND, TEXAS 77478 AND ALL CITIZENS WERE WELCOMED.

LEASE, OR VALUE OF REAL PROPERTY IF DELIBERATION IN AN OPEN MEETING WOULD HAVE A DETRIMENTAL

EFFECT ON THE POSITION OF THE GOVERNMENTAL BODY IN NEGOTIATIONS WITH A THIRD PERSON.

MAYOR ROBERTS ANNOUNCED THAT COUNCIL WOULD ENTER INTO AN EXECUTIVE SESSION

AS 4:12 P.M. AND A QUORUM WAS PRESENT.

III. RECONVENE AND TAKE ACTION ON ITEMS DISCUSSED IN EXECUTIVE SESSION IF DEEMED APPROPRIATE

MAYOR ROBERTS ANNOUNCED THAT WE WILL RECONVENE BACK INTO REGULAR SESSION AT
6:27 P.M. AND A QUORUM WAS PRESENT.

MAYOR ROBERTS ASKED IF THERE WAS ANY ACTION TO BE TAKEN. COUNCIL MEMBER KRENEK STATED THERE IS NO ACTION THAT NEEDS TO BE TAKEN FROM THE EXECUTIVE SESSION..

MAYOR ROBERTS INTRODUCED RON COX OF COX CONSULTING FIRM. IT IS A FIRM WHICH HELPS CITIES TO MANAGE BETTER. THIS WAS A TRAINING SESSION FOR THE CITY COUNCIL KNOWN AS THE FIRST CITY COUNCIL RETREAT- SESSION 1 (GOVERNANCE).

AT 6:30 P.M., MAYOR ROBERTS STATED THAT COUNCIL WOULD TAKE A SHORT BREAK.

A. DISCUSSION ON GOVERNANCE AND GOAL SETTING

MR. COX INTRODUCED HIMSELF TO THE COUNCIL. HE STARTED OFF BY ASKING THE COUNCIL WHY FULSHEAR. IT WAS UNANIMOUS THAT EACH ONE OF THEM HAD A LOVE FOR FULSHEAR. NEXT HE ASKED EACH ONE OF THE MEMBERS WHAT CHARACTERISTICS DO THEY WANT TO KEEP ABOUT FULSHEAR. NEXT THE MEMBERS DISCUSSED THE "GUIDING PRINCIPLES". NEXT THE GROUP TALKED ABOUT THE THREE (3) GOVERNANCE WHICH THEY IDENTIFIED TO BE LEADERSHIP, COMMUNICATION, AND EXPECTATIONS (PROACTIVE PLANNING). THIS SESSION CONTINUED FOR APPROXIMATELY TWO HOURS. AT THE CONCLUSION OF THIS SESSION, IT WAS AGREED THAT IT WOULD HAVE A FINAL MEETING ON AUGUST 2, 2016 FROM 6P-9P TO CONCLUDE THIS TRAINING.
