A SPECIAL CITY COUNCIL MEETING AND WORKSHOP WAS CALLED TO ORDER BY MAYOR JEFF W. ROBERTS ON SEPTEMBER 6, 2016 AT 7:30 P.M. AT THE FULSHEAR CITY HALL LOCATED AT 30603 FM 1093 RD., FULSHEAR, TEXAS 77441 AND ALL CITIZENS WERE WELCOMED.

II. WORKSHOP ITEMS

A. <u>DISCUSSION AND CONSIDERATION OF FISCAL YEAR 2016-2017 GENERAL FUND AND CAPITAL PROJECTS BUDGETS</u>

C. J. SNIPES, CITY ADMINISTRATOR, STATED HE WAS ASKED TO TRIM THE NET BUDGET BY \$100,000. MR. SNIPES PROVIDED THE COUNCIL WITH A HAND OUT. MR. SNIPES PRESENTED AN OVERVIEW OF THE REVISED CHANGES TO THE COUNCIL. HE DISCUSSED THE FOLLOWING 2016-2017 PROPOSED BUDGETS INDIVIDUALLY: OPERATING BUDGET, CAPITAL PROJECTS FUND BUDGET, AND ENTERPRISE FUND BUDGET, AND THE GENERAL FUND BUDGET. HE STATED THAT IT APPEARS WE WILL NEED TO INCORPORATE A NEW SYSTEM (INTER-GULF) TO INTEGRATE WITH OUR CURRENT INCODE SYSTEM. KRISTINA BRASHEAR, FINANCE DIRECTOR, STATED IT WOULD BE COSTLY DUE TO HAVING SOMEONE WITH TRAINED KNOWLEDGE TO IMPLEMENT THE NEW SYSTEM OR WE CAN CONTINUE WITH THE CURRENT SYSTEM AND GET AN UPGRADE WHICH CANNOT OCCUR UNTIL SUMMER OF NEXT YEAR. COUNCIL SPENT APPROXIMATELY AN HOUR AND HALF DISCUSSING THE PROPOSED FOR 2016-2017 BUDGET.

MR. SNIPES PROVIDED AN EXAMPLE TO THE COUNCIL REGARDING THE CURRENT WEBSITE SYSTEM. THE CITY SECRETARY HAS BEEN GIVEN PERMISSIONS TO MAKE ADJUSTMENT TO THE WEBSITE BUT STILL CERTAIN AREAS SHE IS NOT ABLE TO ACCESS EVEN THOUGH IT SHOWS SHE HAS PERMISSION. REVIVE STAFF, (WEBSITE STAFF), HAS BEEN UNABLE TO FIGURE OUT WHAT THE PROBLEM IS. THE DEBATE CONTINUED.

MICHAEL ROSS, ASSISTANT CITY MANAGER, PROVIDED AN OVERVIEW OF POTENTIAL CHANGES FOR THE WATER AND WASTEWATER SYSTEM TO THE 2016-2017 BUDGET. HE ALSO PROVIDED PROS FOR INVESTING INTO THE GIS SYSTEM.

FOR ALL THE COMMENTS, REQUEST A COPY OF THE TAPE RECORDING.

COUNCIL MEMBER GILL REQUESTED THAT CITY MANAGER LOOK TO PROVIDE ALL STAFF WITH A 2% COST OF LIVING INCREASE AND SEE IF THIS CAN BE FUNDED THROUGH ADJUSTMENTS AND TO REVIEW INDIVIDUAL DEPARTMENT BUDGETS TO SEE WHAT COULD BE TRIMMED FROM NEXT YEAR'S BUDGET.
