## SPECIAL CITY COUNCIL WORKSHOP/MEETING MINUTES FEBRUARY 28,2017

#### I. OPENING

#### A. CALL TO ORDER

A Special City Council Workshop Meeting was called to order at 6:32 p.m. by Mayor Jeff W. Roberts Tuesday, February 28, 2017 in the Fulshear City Hall located at 30603 FM 1093 Road, Fulshear, Texas 77441 and all citizens were welcomed. Mayor Roberts thanked everyone for being present and that two members were absent, Stephen Gill and Erin Tristan.

Mayor Roberts requested a short intermission of the meeting to acknowledge that Tim Kirwin of the City Attorney's office (Randall Law Firm) last day is today and also is his birthday. Mayor Roberts acknowledge Mr. Kirwin for his assistance to the City of Fulshear. The audience applauded and song happy birthday to him. Mayor Roberts resumed the meeting.

#### II. WORKSHOP ITEMS

#### A. DISCUSSION AND CONSIDERATION OF CITY OF FULSHEAR EMPLOYEE HANDBOOK

Mayor Roberts introduced Paula Ryan, Human Resource Director/Assistant City Manager, to present to the Council the proposed City of Fulshear Employee Handbook. This book has not been updated since 1986. Ms. Ryan stated that this document has been worked on for over a year to refine with current practices and what is actually being done. Ms. Ryan stated that the proposed document had been sent to department managers and supervisors for comments. Ms. Ryan stated the plan is to get it adopted by next month and bring it back to council at least once a year with updates.

Tim Kirwin, from the city's attorney's office added a few comments. Various council members asked questions about the following: non-exempt employees-compensatory time, uniforms and equipment, drug testing policy, pre-employment process, applicant vs. employee, catastrophic sick leave pool, American disability act regarding reasonable accommodations, salaries, dress code, identify responsibilities of city manager in regards to personnel issues as some places in the manual it states designee (in case of litigation). There were back and forth questions regarding these items between the council members, attorney, city manager, and Ms. Ryan. (for all the specific comments, request a copy of tape recording). Mr. Kirwin offered to send the case law to each council member regarding handbook requirement for drug testing.

Ms. Ryan stated she would make the suggested changes. Mayor Roberts thanked both Ms. Ryan and Mr. Kirwin for their hard work on the proposed employee handbook.

Mayor Roberts reconvened the special workshop meeting at 7:10 p.m.

# B. <u>DISCUSSION AND CONSIDERATION ON CONSENSUS FOR PRIORITIZATION OF ITEMS FOR INCLUSION</u> IN POTENTIAL TREE POLICY

Mayor Roberts stated for this portion of the workshop he will allow comments from the public and that C.J. Snipes, City Manager will present first to the Council. Mayor Roberts stated he would like some directions from the residents ask to whether a tree policy or ordinance is wanted. He also stated that individuals who want to speak to please give their name and was limited to five minutes.

Mr. Snipes presented to the Council and audience to the following:
Ordinance v. resolution, incorporate into zoning, tree preservation v. canopy
management, should apply to new developments and existing, right of way and
easements. He then presented some examples in the various group. These were put on a
video screen so all could view. (for all the specifics, request a copy of the tape
recording)

Both Council Members Krenek and Ridge echoed that they were interested in the comments from the public. Council Member Krenek stated that the feedback should be incorporated into whatever document is adopted. Comments came from Mike Roller, Doug Konopka, Tommy Kuykendall, Ms. Jones, Rob Bamford, Sherri BeMent, Debra Cates, Carol Riggs, Sam Yeager, Cherryl Finney, and Bill Sweitzer which included landowners and developers in this area. For all the specific comments, request a copy of the tape recording.

From the developers side, especially for the downtown area, it was difficult to do quality development when have small lots, drainage, parking, landscaping requirements, and the proposed canopy requirement. For the landowners, it forces them into commercial tax bracket, unable to sell their properties, etc.

Mr. Snipes also talked about the two proposed legislative bills by the State; HB 1572 and Senate Bills 782 and 744 addressing issue on cities being able to regulate trees.

Everyone like having trees but Mayor Roberts stated trees should not take preference over the owners of the property.

Council Member Ashley stated that she supports a resolution. Mr. Snipes was requested to put a copy of the proposed Resolution on the website so residents can review it and send in their comments.

Mayor Roberts thanked everyone for their comments
