I. OPENING

A. CALL TO ORDER

IV. BUSINESS

A. CONSIDERATION AND POSIBLE ACTION TO APPROVESUSPENSION RESOLUTION NO. 2018-374 REGARDING SI ENERGY GAS RATE INCREASE FILING

MS. RYAN, ACTING CITY MANAGER, EXPLAINED TO THE COUNCIL THAT AN INCREASE FROM SI ENERGY GASRATE WOULD MEAN AN INCREASE TO 1100 RESIDENTS WHO RESIDE IN CROSS CREEK RANCH AND TWO COMMERICIAL CUSTOMERS. THE RATE INCREASE WOULD BE \$10.53 FOR RESIDENTIAL CUSTOMERS AND 23 AND HALF PERCENT TO THE COMMERCIAL CUSTOMERS PER MONTH. THIS RESOLUTION WILL DELAY THE EFFECTIVE DATE OF THE RATE CHANGE BY 90 DAYS AND ALLOW THE CITIES TO RETAIN LEGAL AUTHORITY OVER THE MATTER. THERE WAS A SHORT DISCUSSION AMONG THE COUNCIL MEMBERS.
