# SPECIAL CITY COUNCIL MINUTES MARCH 3, 2018

#### 1. **OPENING**

# A. CALL TO ORDER

A SPECIAL CITY COUNCIL MEETING WAS CALLED TO ORDER BY MAYOR JEFF W. ROBERTS ON MARCH 3, 2018 AT 8:34 A.M. IN THE FULSHEAR CITY HALL LOCATED AT 30603 FM 1093 RD, FULSHEAR, TEXAS AND ALL CITIZENS WERE WELCOMED.

# B. QUORUM AND ROLL CALL

MAYOR ROBERTS ANNOUNCED THAT A QUORUM WAS PRESENT. HE STATED THAT COUNCIL MEMBER FATHEREE WAS ABSENT.

COUNCIL MEMBER KUYKENDALL ASKED IF HE COULD MAKE A COMMENT BEFORE GOING INTO EXECUTIVE SESSION. HE STATED THROUGHOUT HIS CAREER, HE HAS ALWAYS RESPECTED THE ROLE AND THE FUNCTION AND BODY OF THE EXECUTIVE SESSION AND THINGS STAY FAIRLY CLOSED IN THAT ENVIRONMENT BUT THIS LAST WEEK THAT A LOT OF INFORMATION COMING FORTH FROM EXECUTIVE SESSION. HE STATED ONE OF THINGS COMING FORTH FROM YOUR WIFE (REFERRING TO MAYOR'S WIFE) TO WAIT AND LET NEW COUNCIL HIRE A CITY MANAGER AS THEY WILL BE THE ONES WORKING WITH THE NEW CITY MANAGER FOR THE NEXT TWO YEARS. HE STATED COUNCIL REFUSED AND WHILE I RESPECT THAT MEETING THAT WE HAD----WE WERE IN THE MEETING TOGETHER AND MOVE THIS PROCESS FORWARD. WE HIRED THE BEST FIRM THAT IS AVAILABLE TO SELECT A NEW CITY MANAGER. HE STATED THAT OUR PROCESS IS BEING DERAILED BY FALSE INFORMATION COMING OUT OF EXECUTIVE SESSION. MAYOR ROBERTS STATED THAT WE NEED TO MOVE THE PROCESS ALONG. COUNCIL MEMBER GILL INSISTED ON MAKING A STATEMENT. (FOR ALL THE COMMENTS, REQUEST A COPY OF THE TAPE RECORDING)
