I. CALL TO ORDER

A SPECIAL CITY COUNCIL MEETING WAS CALLED TO ORDER BY MAYOR GROFF VIA VIDEOCONFERENCE AT 1:01 P.M. A QUORUM WAS PRESENT.

IV. BUSINESS

A. CONSIDERATION AND POSSIBLE ACTION TO RECORD RECEIPT OF 2020 CERTIFIED APPRAISAL ROLL AND COLLECTION RATE AS REQUESTED BY THE COUNTY TAX ASSESSOR/COLLECTOR

JACK HARPER EXPLAINED TO COUNCIL THAT WE HAVE NOT RECEIVED THE CERTIFIED TAX ROLL FROM THE APPRAISAL DISTRICT.

WES VELA EXPLAINED THAT AT 12 O'CLOCK (TODAY), HE RECEIVED A CALCULATION FROM FORT BEND COUNTY (UNOFFICIAL).

THERE WAS NO ACTION FROM THIS ITEM.

B. REVIEW AND DISCUSSION OF FY2021 PROPOSED OPERATING & CAPITAL BUDGET

WES VELA REVIEWED A SLIDE PRESENTATION REGARDING THE BUDGET OVERVIEW. HE EXPLAINED THE BUDGET CALENDAR AND NEW CITY POSITIONS (REQUESTED) WITHIN THIS BUDGET.

DAN MCGRAW GAVE AN OVERVIEW OF SCENARIO #3 FROM THE UTILITY FUND ON PAGE 6
OF THE SLIDE PRESENTATION. THIS SCENARIO WOULD BRING UTILITY OPERATIONS INHOUSE. DURING HIS STAFFING PLAN, DAN EXPLAINED THAT THIS WOULD CREATE THE NEED
FOR MORE OFFICE SPACE AND HE EXPLAINED THE USE OF A MODULAR BUILDING.

TECH 1 WAS HIRED IN FEBRUARY AND TECH 2 IS IN THE PROCESS OF HIRING NOW. THIS SCENARIO WOULD BRING ON 6 EMPLOYEES AND INFRAMARK WOULD CONTINUE ON A CONTRACT BASIS. DAN AND SHARON ANSWERED QUESTIONS FOR COUNCIL.

WES WENT THROUGH THE PROPERTY TAX RATE AND VALUES AND COMPARISONS. HE ALSO WENT THROUGH THE GENERAL FUND ASSUMPTIONS FOR FY2021, GENERAL FUND EXPENDITURES BY DEPARTMENT AND ANSWERED QUESTIONS.

JACK HARPER AND BYRON BROWN DISCUSSED THE OPTION OF BRINGING AN ATTORNEY IN-HOUSE FULL-TIME AND ANSWERED QUESTIONS FROM COUNCIL.

COUNCIL MEMBER CATES REQUESTED A SUMMARY OF THE LEGAL WORK DONE FOR THE CITY.
