- 2. THIS IS AN ESTABLISH SCHOOL ZONE THAT IS EASILY RECOGNIZABLE TO ANYONE IN THE SCHOOL ZONE ON EITHER STREET*

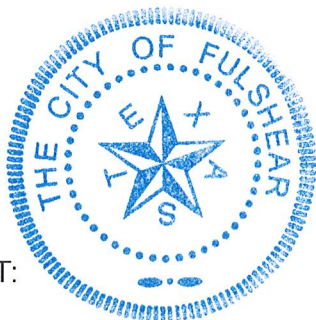
VI. ADJOURNMENT
