- RATE OF \$11.44 PER ACCOUNT, PER MONTH FOR RESIDENTIAL CUSTOMERS WILL BEGIN OCTOBER 1, 2023 (100% OF THE PROPOSED RATE).

#### **RECYCLING SERVICE:**

• RATE OF \$5.29 PER ACCOUNT, PER MONTH FOR RESIDENTIAL CUSTOMERS (100% OF THE PROPOSED RATE).
