CLIFF EXPLAINED THAT WE HAVE CONSISTENTLY STAYED IN BUDGET BUT WITH THE INCREASE IN INSPECTIONS SERVICES THIS YEAR THERE HAS BEEN A SUBSTANTIAL INCREASE IN OUR MONTHLY BILL. HE STATED WE PROJECTED OUT THE REMAINDER OF THE YEAR AND DETERMINED AN \$200,000.00 WAS NEEDED.
