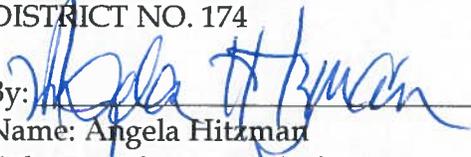

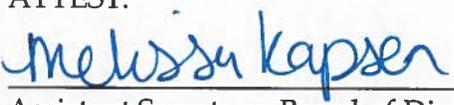

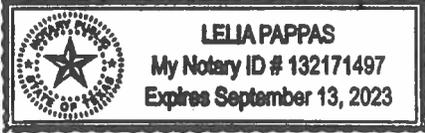

Please note the high percentage of budget used for Emergency Management is due to the allocation of the CARES Act Funding. The City will be reimbursed for these expenses.

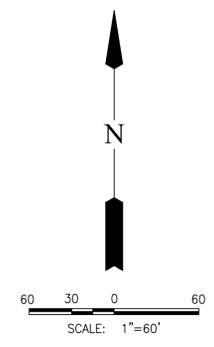

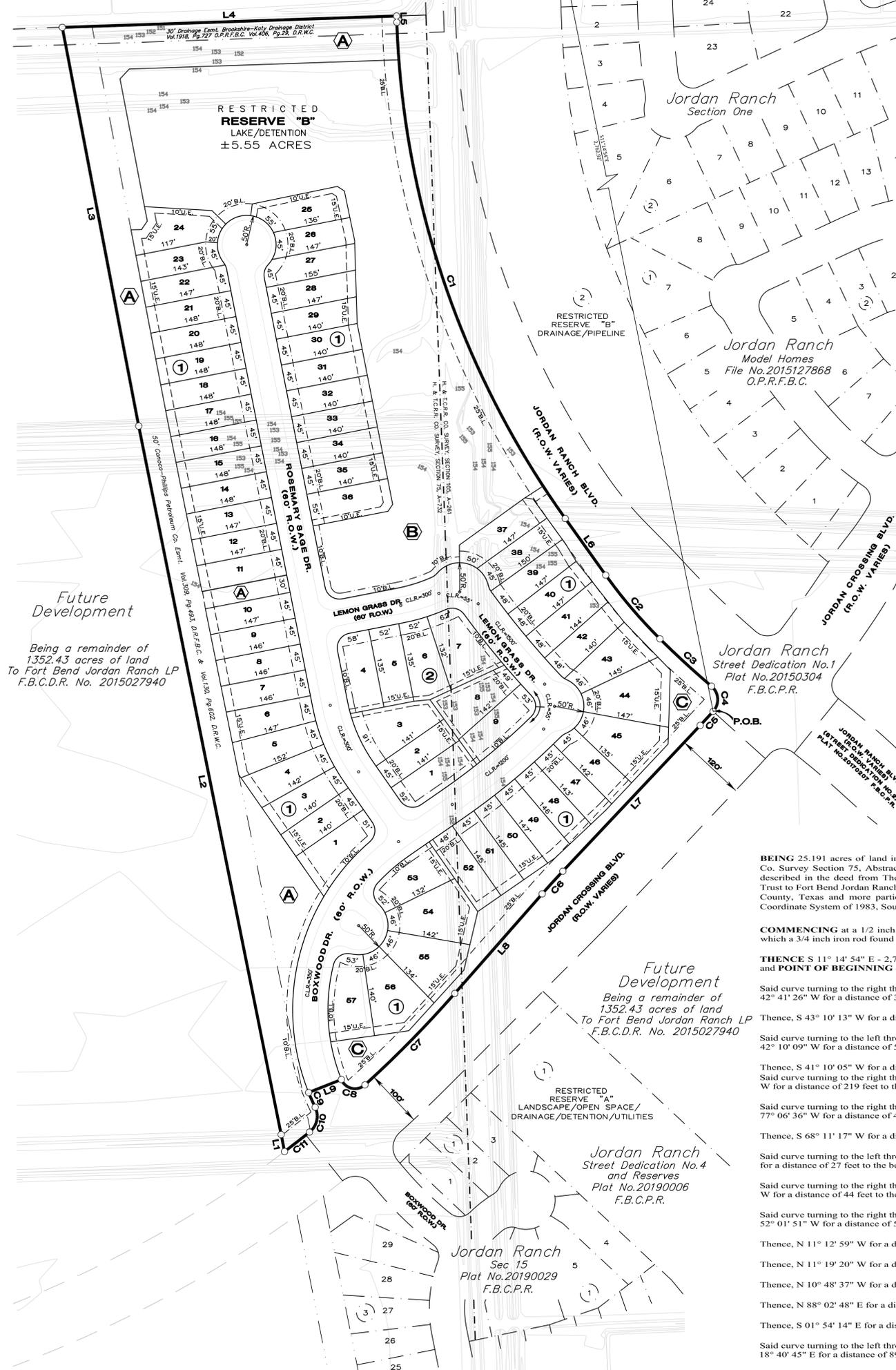


Vicinity Map

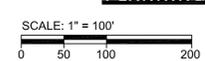
