EXECUTIVE SUMMARY

In 2016, McManus and Johnson Consulting Engineers, Inc. was selected to perform a utility rate study to analyze specific variables associated with the City's utility system. The goal of the study was to establish a rate structure consistent with the City's desired rate philosophy and which also provides adequate revenue for operational needs. The study was postponed for some time as discussions with the in-city MUDs continued so that the variables for a combined system could be considered in this process. Once the initial terms of the amendments to the in-city MUD agreements were established, McManus and Johnson were asked to proceed with the rate study and consider the following basic guidelines:

- 1.) Create a uniform rate structure for all meter user classes and an industry-standard for scaling base rates in line with meter sizes.
- 2.) Establish a rate philosophy that focuses on consumption and utilizes a tiered consumption rate schedule that encourages conservation.
- 3.) Realize economies of scale from the combination of utility systems made possible via the amendments to the in-city MUD agreements
- 4.) Lower monthly base rates by \$7.50 each (\$15 total) for both water and wastewater customers.
- 5.) Explore the possibility of winter averaging for residential wastewater service.
- 6.) Review other relevant factors concerning operations and growth that may affect revenue.

With those factors in mind, the rate study has been completed representatives of McManus Johnson will present those findings. Both City Staff and McManus Johnson will be able to answer any questions City Council may have. City Staff is requesting direction to finalize the proposed rate structure and prepare the ordinance changing the rates.

RECOMMENDATION

City Staff recommends City Council provide direction for the proposed rate structure and the ordinance implementing the new utility rates.

EXECUTIVE SUMMARY

Based on direction provided by the City Council in June 2019, City Staff initiated a Request for Proposals to provide interested parties an opportunity to propose potential project options for the restoration, re-creation, or re-use of salvaged materials from the Section House located in Frances Smart Park. At the conclusion of that process, the City received no formal responses to the RFP. Previously, recommendations from the Historic Commission and the Parks & Recreation commission involved the restoration of the building for a civic use. Information received from previous inspections of the home provided varying opinions regarding the costs of restoration, re-creation, and the potential salvaging of materials for future use. At this time, City Staff is requesting direction regarding the future of the Section House. Any related costs resulting from Council's direction would be covered by budgeted funds in the FY20 Facilities and/or Parks budget.

RECOMMENDATION

City Staff has no recommendation at this time, but would request City Council provide formal direction for the next steps of the Section House project.
