#### **EXECUTIVE SUMMARY**

In an effort to relieve traffic congestion associated with the FM 1093 project, the office of Fort Bend County Precinct 3 approached the City about constructing a temporary asphalt roadway from Charger Way to Katy-Fulshear Road. Several routes were discussed and the County ultimately accepted a suggestion by City Staff to consider a route at the northern end of Charger Way to Katy-Fulshear Road north of Huggins Drive.

In order for this project to occur, City Council would need to consent to this construction per Chapter 251 of the State of Texas Transportation Code.

That section header is as follows:

Sec. 251.012. COUNTY AUTHORITY IN MUNICIPALITY. (a) With the approval of the governing body of a municipality, the commissioners court of a county may spend county money to finance the construction, improvement, maintenance, or repair of a street or alley in the county that is located in the municipality.

It is the understanding of City Staff that FBC Pct. 3 officials contacted the owner of the land and received consent to construct this temporary roadway. In addition, City Staff was informed that the Fort Bend County Commissioners Court has also approved this item pending approval of City Council.



Subject: TEMPORARY ACCESS EASEMENT

Honorable Mayor Groff and City Council,

Fort Bend County wishes to enter into an agreement for a temporary access easement with CCR Texas Holdings, LP (Cross Creek Ranch and Johnson Development), in order to construct a temporary road from Charger Way to Fulshear Katy Road. The Commissioner's Court will be taking action on this agreement at our November 5<sup>th</sup> meeting, and I will make the motion to approve contingent on consent of this agreement by the Fulshear City Council.

The terms of the agreement, and the exhibit, are attached for your review. To summarize our easement agreement:

- 1. Cross Creek Ranch will grant a non-exclusive temporary access easement to Fort Bend County from Charger Way to Fulshear Katy Road, measuring approximately one hundred feet (100') in width.
- 2. Fort Bend County will have access to an additional fifty feet (50') of right-of-way to accommodate any excavation work, operate machinery, and do any necessary clearing.
- 3. The term of the agreement will run until January 1, 2021, or when the improvements to FM 1093/Westpark Tollway Phase II-B are substantially complete (whichever occurs first).
- 4. Fort Bend County will maintain the easement and temporary roadway until the agreement expires.

#### TEMPORARY ACCESS EASEMENT

This Dedication of Temporary Access Easement (this "Temporary Dedication"), is made and entered into by CCR Texas Holdings, LP, a Delaware limited partnership ("CCR").

WHEREAS, CCR owns a certain tract or parcel of land containing approximately 310.3054 acres in the Fulshear, Texas area, (the "Property"), described on Exhibit A attached hereto and incorporated herein for all purposes; and

WHEREAS, recent improvements to FM 1093/Westpark Tollway near the Property have created traffic delays and risks of injury to citizens of Fort Bend County, Texas (the "County"); and

WHEREAS, CCR desires to dedicate to the Public a temporary non-exclusive access easement for ingress and egress upon, over and across a portion of the Property extending approximately one hundred feet (100') in width from Charger Way to Katy Fulshear Road to relieve congestion during improvements to FM 1093/Westpark Tollway, as depicted on Exhibit A.

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, CCR hereby agrees as follows:

- 1. <u>Temporary Access Easement</u>. CCR dedicates to the Public, a non-exclusive temporary access easement on, over and across the Property for vehicular ingress and egress access from Charger Way to Katy Fulshear Road measuring approximately one hundred feet (100') in width, as depicted on Exhibit A (the "Easement").
- 2. <u>Construction of Temporary Road</u>. Further, CCR dedicates this Easement to permit the County, any and all of its agents, officers, servants, employees and contractors, to enter upon the Easement on behalf of the Public and install, construct, and maintain a temporary roadway within the same, ("Temporary Roadway"). During construction of and maintenance operations for the Temporary Roadway, the County may spread spoil dirt and excavated material, operate machinery and, do any necessary clearing upon the Property immediately adjoining the Easement within an area of right of way not to exceed fifty feet (50') north of the proposed Temporary Roadway.
- 3. <u>Term.</u> The term of this Temporary Dedication shall begin upon execution and terminate on January 1, 2021, or when improvements to FM 1093/Westpark Tollway Phase II-B are substantially complete, whichever occurs first. This Temporary Dedication shall remain in effect for the duration of such improvements and cancelled upon its substantial completion.
- 4. <u>Encumbrances</u>. The Easement created herein shall be subject to all validly existing restrictions, covenants, conditions, right-of-way, easements, mineral reservations and royalty reservations, and all other matters of record, if any, affecting the Property as of the date of execution.

- 5. <u>Maintenance</u>. The County will maintain the Easement and the Temporary Roadway during the term of this Temporary Dedication.
- 6. <u>Drainage</u>. Existing drainage conditions shall be contained in the existing drainage ditches and swales.

TO HAVE AND TO HOLD the above described Easement for the said purposes, together with all and singular, the rights, privileges, and appurtenances thereto as described above, in anywise belonging to the Grantee, subject to the limitations, conditions and restrictions set for herein.

IN WITNESS WHEREOF, the Temporary Dedication has been executed and shall be effective as of the date set forth below.

# Organizational Structure & Governance – Home Rule Charter

Home Rule Charter – Enacted in 2016

Charter Sec. 8.07 - Charter Review Commission

- Requires review within 5 years of adoption
- Establishes rules and procedures for the Commission

## Texas Constitution on Charter amendments

Not more often than 2 years

# Per City Attorney:

- Charter can be reviewed now (more than 2 years after adoption)
- Charter must be reviewed at least every 5 years
- Charter may not be changed more than every 2 years
- Any changes made then resets the clock and no charter changes can be made for the next two years after.
