ORDINANCE NO. 2023-1436 AN ORDINANCE ADOPTING THE CITY OF FULSHEAR'S FISCAL YEAR 2023-2024 BUDGET

AN ORDINANCE OF THE CITY OF FULSHEAR, TEXAS, MAKING APPROPRIATIONS FOR THE SUPPORT OF THE CITY OF FULSHEAR FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024; APPROPRIATING FUNDS FOR ALL CITY FUNDS INCLUDING THE GENERAL, ENTERPRISE, SPECIAL REVENUE AND CAPITAL IMPROVEMENT PROGRAM FUNDS. FINDING THAT ALL THINGS REQUISITE AND NECESSARY HAVE BEEN DONE IN PREPARATION AND PRESENTMENT OF SAID BUDGET; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE HEREOF.

WHEREAS, the Charter of the City of Fulshear, Texas, and the Statutes of the State Texas, require that an annual budget be prepared and presented to the City Council of the City of Fulshear, Texas, prior to the beginning of the fiscal year of said City, and that a public hearing be held prior to the adoption of said Budget; and

WHEREAS, the Budget for the fiscal year October 1, 2023, through September 30, 2024, has heretofore been presented to the City Council and due deliberation had theron, was filed in the office of the City Secretary on August 18, 2023, and a public hearing scheduled for September 5, 2023 was duly advertised and held.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FULSHEAR:

<u>SECTION 1</u>: That the Budget for the City of Fulshear, Texas, now before the said City Council for consideration, a complete copy of which is on file with the City Secretary and incorporated herein by reference, is hereby adopted as the Budget for the said City of Fulshear, Texas, for the period October 1, 2023 through September 30, 2024.

<u>SECTION 2</u>: Be it FURTHER ORDAINED, that the said City Council finds that all things requesite and necessary to the adoption of said Budget have been performed as required by charter or statute.

<u>SECTION 3</u>: The City Council offically finds, determines, recites and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this Ordinance and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

<u>SECTION 4</u>: The City's budget officer is hereby directed to cause a copy of the budget, including the cover page, to be posted on the City's website, to cause the record vote on the adoption of the budget to be posted on the City's website at least until the first anniversary of this Ordinance, and to cause the cover page of the budget to be amended to include the property tax rates for the current fiscal year if the rates are not included on the cover page when the budget is filed with the City Secretary.

SECTION 5: In the event any clause phase, provision, sentence, or part to this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Fulshear declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

SECTION 6: This Ordinance shall be in effect from and after its passage and approval.
