1. Call to Order

There being a quorum, Tommy Kuykendall called the meeting to order at 6:01 p.m.

2. Public Comments - Citizens who desire to address the Corporation making either general comments (i.e., matters not on the agenda) or regarding matters on the agenda will be received at this time. Citizens desiring to make comments must register with the Corporation prior to the meeting being called to order. The number of speakers will be limited to the first ten (10) speakers and each speaker is limited to three (3) minutes. Discussion by directors regarding matters on the agenda will only be made at the time the subject is scheduled for consideration.

In accordance with the Texas Open Meetings Act, the Corporation may respond to a general comment by (1) responding with a statement of specific factual information or (2) recite the Corporation's existing policy on that issue. The Corporation may also direct the person making the general comment to visit with staff about the issue, or the Corporation may offer to place the item on the agenda for discussion at a future meeting.

3. Consideration and possible action on EDC support of the Fulshear Farmers' Market.

Representatives from the Fulshear Farmers' Market, Kayleen Nelson and Ramona Ridges, presented information about the impact of the Farmers' Market on the community. The representatives highlighted the percentages of visitors from outside the city that the market brings, as well as its reach around the region for specialized vendors. Two funding requests were presented:

- 1. \$300 per weekend (\$15,600) for the hiring of local musicians to perform at the Market
- 2. A one-time funding of \$7,000 for beautification and structural updates to their facility

Due to the influx of outside visitors and interest to the community, justification for funding under the Advertising and Promotion allowance granted to both Type A & B Boards is valid.

Motion to grant 50% of the funding to the Fulshear Farmers' Market for a one-time payment of \$7,000 (\$3,500) and \$300 (\$150) per weekend through the end of FY23.

Annel Guadalupe noted the various development meetings and projects that have taken place since the last regular meeting.

b. Retail Coach Update

Aaron Farmer of the Retail Coach provided a memo to staff highlighting the positive momentum and potential being realized within the city.

c. Update on EDC website & Explore Fulshear Magazine

The EDC website is now under staff review and is in the final stages of its production. Staff hopes to have the site live within the next few months. Additionally, final design and content for ad space in the Explore Fulshear magazine was submitted and will soon be out for print.

d. Update on RFQ for long-term legal counsel

The RFQ document was reviewed by legal counsel and will be posted this month.

e. Update on Fulshear Entrepreneurship & Business Hub

The first draft of the Business Hub contract was reviewed by legal and is now with staff for initial modifications. It will likely return for a first round of comments at the July EDC meeting.

f. Update on Hotel Feasibility Study

The Hotel Feasibility Study has been completed and shows positive indication that a smaller-format hotel would perform well in the city.

- g. Launch of "The Best of Fulshear" Photography Contest
  - EDC and city staff have developed a photography contest to showcase the talents of our community and to decorate the new Municipal Complex. Details of the contest will be posted on City social media, and will be highlighted at the May 16, City Council meeting.
- h. New Businesses & Developments to Fulshear

Main Squeeze Juice Co. recently opened a store along FM 1463. Additionally numerous multifamily developments are opening throughout the city, a positive sign for attracting retail growth to the city.

5. Consideration and action on financials and payables for the period ending March 31, 2023.

Staff addressed a question raised at the May 8, 2023, Special Meeting regarding a significant increase in the fund balance between January and March. Staff informed the Boards that the increase resulted from the recently purchased property being added as an asset to the fund balance. Members requested that a cash balance popout be included in future financial statements.

Kaye Kahlich raised a question regarding the fluctuation in ASA reimbursements seen in the statements. Staff informed the Boards that an answer would be provided at the next meeting.

6. Review, discussion, and possible action concerning the funding of CIP Projects for the 2023-2024 fiscal year. (Moved to Item 4)

During the May 8, 2023, Special Meeting the Boards asked that the following questions be addressed:

- Specificity on lighting buildout
  - o Conduit is scheduled to be assessed in the scope of this project, but new lighting fixtures are not. Existing lighting will remain in the interim.
- Potential for the City to accelerate other aspects of the Livable Center projects
  - The city has already made significant steps in completing the projects outlined in the LCS; they will continue to be addressed as funding becomes available
- Possibility of a zoning overlay within the downtown district to limit residential use
  - An update to the CDO expected to be heard in June at the Fulshear City Council meeting addresses this concern by stating that new construction on the frontage on Harris Street must have ground-floor retail
- Future phasing of downtown improvements

Harris Street and the reconstruction of Wallis are the top priority as of now;
 Eastside Drainage and other downtown projects well be addressed as the previous are completed

Director of Public Works, Sharon Valiante, presented another brief overview on the request for funding from both CDC and FDC Boards. James Buccieri and Bryan White (CDC) presented the idea of shifting a higher percentage of the cost to the CDC due to the limitations the board would face following the end of FY23.

Motion to forgo the funding of the FY23 Eastside Drainage Project (\$625,000) and to fund half (\$1,540,000) of the Harris Street Improvement Project for the FY24 Budget Year.

9. Consideration and possible action on authorization of an updated demographic study through PASA for \$8,300 (\$4,150 Per Board).

Staff highlighted the need for updated demographic figures for attraction and retention of businesses Fulshear. Through negotiations with other departments in the city who would also benefit from an updated study, staff was able to procure funding assistance totaling \$6,000 dollars. This results in a difference of \$8,300.
