NATIVE PECAN TREES. HE EXPLAINED WHY THE TREES ARE SO IMPORTANT TO HIM. HE WOULD LIKE TO SEE THE CITY REQUIRE A PERMIT BEFORE THEY CAN DESTROY A TREE.

COUNCIL MEMBER JOHNSON PRESENTED PICTURES OF SOME OF THE LARGE PECAN TREES THAT WERE CLEAR CUT. SHE EXPLAINED THESE LARGER TREES SHOULD BE PRESERVES AS LONG AS THEY ARE HEALTHY OR AT RISK TO PUBLIC DESTRUCTION.

ONE EXAMPLE TO PRESERVE THESE TREES IS THE ROAD ON SHADY LANE WITH A TREE IN THE MIDDLE OF THE ROAD.

COUNCIL MEMBER KNAPE IS IN SUPPORT OF AN ORDINANCE BUT WOULD LIKE SOME MORE TIME TO REVIEW THE MATERIAL.

COUNCIL MEMBER BARON GAVE THE IDEA OF A TREE REGISTRY FOR THE SIGNIFICANT TREES.

COUNCIL MEMBER CATES STATED SHE IS IN SUPPORT OF TREE PRESERVATION AND WOULD ALSO LIKE MORE TIME TO LOOK OVER AND REVIEW THE MATERIAL.
