Driving Safety Course Request: Citation Number: _____

You are eligible to take a driving safety course if:

- You have a valid Texas driver’s license that is **NOT a commercial driver’s license**;
- You can show proof of financial responsibility (insurance – YOU MUST BE A LISTED DRIVER ON THE POLICY);
- You have not requested and taken a driving safety course in order to have a ticket dismissed in the preceding 12 months from the date of this offense;
- The offense did not occur in a construction zone when worker’s were present;
- You were not speeding 25 mph or more over the legal speed limit;
- You were not operating a commercial motor vehicle; and
- You did not pass a school bus while children were loading/unloading.

You must make a written request to the court to complete DSC **BEFORE** you complete the driving safety course. To make your written request to complete a driving safety course, you must upload to municipalonlinepayments.com on or before your court date:

- A plea of GUILTY or NO CONTEST by checking the appropriate box above;
- A copy of your driver’s license;
- A copy of your current insurance card;
- **The affidavit below (must be signed and notarized)**; and
- Make an online payment in the amount of **\$144.00** or **\$169.00** if violation occurred within a **school zone**.

Upon receipt of your request and payment, you will **then** have **90 days to**: Submit the DSC completion certificate (Court Copy) to the court signed by you <https://tdlraproved.com/> along with your 3A driving record www.texas.gov by email to court@fulsheartexas.gov, by mail or in person at 6611 W. Cross Creek Bend Ln. Fulshear, TX77441.
